Hello everyone,

I'm commenting today to remind this Board, Emergency Operations people, Joint Information Center, Department of Health, Sheriff etc who were and are involved with the fraudulent local health emergency for Covid-19 that this Board of Supervisors is required by law (Health and Safety code 101080) to terminate the local emergency at the earliest possible date that conditions warrant.

A requirement of the law, which this Board of Supervisors has been in violation of. Furthermore...

As litigation surrounding the massive government overreach due to Covid-19 policy plays out in the courts, I would like to further remind this Board and their staff that on August 4th 2020, Mammoth Group petitioned this local government for redress of grievances about Covid-19 policies.

In this redress of grievances, Mammoth Group asked this local government to emphasize people's rights and educate the public about these rights, in order to prevent division and conflict in the community. To be specific here, this Board and their staff were asked to emphasize the health opt out and other opt outs for the masking policy, including those covered by California Civil Code 51, such as religious exemptions.

No actions were taken by this board or their staff to address our grievances. No actions were taken by this board or their staff to emphasize people's RIGHT TO NOT wear a face covering. And as a direct consequence of this board and their staff's actions and inactions, myself and others rights were deprived under color of law.

As a direct result of the one sided covid-19 policy, which violates numerous state and federal laws, myself and others became victims of threat, intimidation, coercion, and assault, by people who were under the impression that one absolutely must wear a mask. This was a direct consequence of this Board and their staff's policy decisions. Due to the virulent nature of people under the misconception from this local government's Covid-19 policy, myself and others were intimidated and coerced into altering our lifestyle decisions.

We were successfully deterred our rights secured by the laws of this state for fear of and the nuisance of becoming a victim of threat, intimidation, coercion, assault and battery by people indoctrinated by your Covid-19 policies.

Our rights secured, such as being entitled to the full accommodation, advantages, facilities, privileges, or services in all business establishments of every kind whatsoever.

Including but not limited public transit, Mammoth Mountain, and other good and services available to the public via local businesses.

Let me reiterate this again.. in an attempt to make this point VERY CLEAR. This board and their staff's one sided Covid-19 policy decisions, attempted to and actuality deprived people of their rights and DIRECTLY endangered peoples lives and safety causing undue stress!
