

Message from the District Attorney





About the Mono County DA's Office

The position of District Attorney is a Constitutionally Independent Elected Officer who operates solely for the well-being of Mono County and its citizens. As a representative of the People of the State of California, the District Attorney's Office has the critical responsibility to investigate and prosecute all criminal matters in the County of Mono.

We collaborate with every component of the criminal justice system as well as the entire community. We strive to earn and hold the trust and confidence of our community by performing our jobs at the very highest level of professionalism. We accomplish this by approaching every situation with integrity, compassion, mutual respect, open communication, and the highest ethical standards when engaging with everyone from fellow employees to community members.

We attempt to minimize the impact of the criminal justice system upon the lives of victims, witnesses and their families by helping them to overcome the effects of crime.


Along with our prosecution duties, the Office of the District Attorney also handles a wide variety of other services for the county and its citizens. Our other responsibilities include providing assistance to victims and witnesses of crimes by assisting in the restraining order process, and providing legal counseling and referrals.

We provide legal and investigative assistance to other law enforcement agencies throughout Mono County. We protect the environment and serve as the Public Administrator for estates. The District Attorney is the Grand Jury advisor and plays an integral part in numerous multi-agency and community solution groups.

The District Attorney has two offices servicing the entire county area: a south county office located in Mammoth Lakes and north county office located in Bridgeport. The District Attorney's Office is central to the law enforcement community in the way that all law enforcement activities regarding the prosecution of crimes in the entire county funnel through the District Attorney's Office. The Office reviews and prosecutes approximately 1,000 cases per year while at the same time handling its other responsibilities.

DAVE ANDERSON Assistant District Attorney


BRAD BRAATEN Deputy District Attorney


SARAH GILLESPIE Victim Witness Coordinator




CURTIS HILL Temporary Investigative Assistant



Priorities of the District Attorney

The District Attorney is elected into office every four years. It has been a practice of the District Attorney to identify specific areas which are his priorities for protecting the health and safety of the citizens in Mono County. These priorities are usually based on the current crime treads within the county and reflect a targeted effort to combat these crimes.





Changing the Domestic Violence Cycle

Domestic Violence kills three women every day in America. The typical domestic violence victim endures endless forms of abuse before either serious injury or death occurs. It is the goal of the District Attorney to break this cycle of abuse before it leads to injury or death. We hold even first-time offenders accountable for their actions, even if they have never been in trouble with the law before. It is important to get involved early and not only to hold violators accountable, but also to also address the reasons for the abuse. The hope is that we can curb the behavior and prevent the long term abuse a victim may endure before a serious event occurs. This is a crime that must be addressed and a cycle that must be stopped.

Protecting Children

One of the most important priorities of the District Attorney is protecting children. Sexual, physical and emotional abuse of children are some of the most heinous crimes committed.

Children are often abused by people who are entrusted with protecting them. These crimes leave lifelong scars and trauma on these young victims. Individuals who prey on children are some of the most despicable individuals in society.

The Mono County District Attorney is dedicated to the protection of our children and has committed the resources needed to effectively investigate and prosecute individuals who prey on children. Over the past five years, the Mono County District Attorney has sentenced individuals to a cumulative of over 400 years in prison for their crimes against children.

Investigators, prosecutors and medical professionals are part of a team that is specially trained to handle these cases. These professionals are dedicated to seeking justice for these victims. Over the last several years, the Office has received many referrals for cases involving the abuse and/or neglect and endangerment of children. Several are highlighted on these pages.

Protecting the Environment

The Mono County District Attorney has been committed to fighting for and protecting our natural resources and to hold individuals and companies accountable by allocating resources to address these crimes. Polluters know that the Mono County District Attorney will protect the air quality, soil, and waterways from companies and entities that dump harmful pollutants into the beautiful and pristine environment of Mono County.

Further, the Office of the District Attorney pursues individuals and cartels that operate large scale illegal marijuana gardens on public lands, creating a danger to the public and to our recreational users of these lands. Unfortunately, hunters, hikers, and others that come across these types of gardens and the individuals who attend to these gardens put themselves in great danger. Along with the public danger there are also serious environmental impacts that these marijuana gardens create.







CRIME CLASSIFICATION



Bureau of Investigations

The Office of the District Attorney has a highly trained Investigations Unit. This Unit is made up of experienced law enforcement officers who come from highly diverse law enforcement backgrounds. These officers bring vast amounts of experience in investigating crimes as well as expertise in specific investigations. These officers head up internal and external teams and units to address some of the most serious crimes that occur in Mono County.

The Bureau also works closely in investigating cases with detectives and officers from other countywide and state law enforcement agencies. By bringing all the law enforcement agencies together, personnel are assembled to work cases collaboratively, resulting in a more efficient investigation and therefore minimizing everyone's efforts and duplication. Each victim, witness, and suspect are subjected to a comprehensive interview on scene or as soon as possible thereafter. A case receives immediate attention and is completed, submitted, filed, and prosecuted in a shorter amount of time.

Often there are four or more officers assigned to work together on a serious investigation and the casework is divided among all available personnel for a comprehensive investigation. Officers within the Bureau are on call 24/7 and when needed are available to assist and support other agencies personnel while sharing their expertise to assure the best outcome is reached for each investigation.


Sexual Abuse Response Team (SART)

The District Attorney's Office prosecutors and investigators spearhead this working group of assigned law enforcement and healthcare personnel. The Team meets monthly and discusses all sex crimes cases which are either pending investigation or prosecution.

The Team employs a multi-disciplinary approach and interacts with Child Protective Services to minimize the possibility of causing a victim to suffer further trauma during the investigative process.

In a notable case several years ago, it was the work and concept of the SART team which resulted in a local daycare provider, Lupe Almaguer, to be sentenced to over 60 years without the victims having to testify and recount the trauma. A similar case is highlighted to the right.

Good case investigations result in successful prosecutions, and good investigations are conducted when all the experience and knowledge in Mono County is applied to a single case. It is this team approach that leads to successful outcomes on behalf of the victim.


Special Prosecutions Unit (SPU)

The Special Prosecutions Unit handles cases that require special attention and receive high public attention. The Unit investigates and prosecutes individuals who violate public trust or commit criminal violations of state laws that regulate the conduct of elected or appointed public officials and employees, including law enforcement.

Holding public officials accountable for violating public trust is important in promoting the democratic process and keeping government free of corruption. Lifetime bans from holding public office can be imposed in cases involving public officials who abuse their official positions for personal and/or financial gain.

The Unit also investigates compliance with the open meeting requirements of the Ralph M. Brown Act and the Bagley-Keene Act. These requirements protect, promote and strengthen transparency and accountability in local elected or appointed governmental bodies vital to the functioning of democratic institutions. Holding law enforcement officers and government officials to a high standard is crucial in maintaining public confidence in all criminal justice matters, and the Unit prosecutes cases against individuals who hold these positions.

The Unit is also is responsible for upholding the professional integrity of licensed professionals, such as doctors and attorneys, in the course of performing their duties.



Child Abduction

Under California Family Code 3300 et seq the District Attorney is charged with carrying out child custody investigations and acting in court on behalf of the child in disputes where one parent has concealed, kidnapped, or abducted their child from the other parent. These cases are contentious and time consuming, and often involve other Counties, States, and Nations.

The Mono County District Attorney's Office has worked several international cases where a parent in Mexico alleged the parent in Mono County has abducted and concealed a child. At present the Office does not have any open international cases, and only one California case is open.



Internet Crimes Against Children

The Internet Crimes Against Children Task Force Program (ICAC) is a national network of 61 coordinated task forces representing more than 4,500 federal, state, and local law enforcement and prosecutorial agencies.

These agencies are engaged in both proactive and reactive investigations, forensic examinations, and criminal prosecutions. By helping state and local agencies develop effective, sustainable responses to online child victimization including responses to child sexual abuse images, the ICAC Program has increased law enforcements capacity to combat technology facilitated crimes against children at every level.

The Mono County District Attorney's Office is the designated law enforcement agency in Mono County, who receives all ICAC referrals involving online child victimization and exploitation and conducts investigations within the Eastern District of California as well as works with federal agencies and ICAC task forces throughout the United States. Most of the investigations focus on sex crimes committed upon children in which a computer was used to facilitate the crime.

The task force also conducts education for children. adults, and community groups to help them learn to be safer on the Internet and thereby hopefully reducing online victimization.

Drug Traffickers and Narcotics

Drugs have a major impact to Mono County. Drugs wreak havoc on people, their families and friends, and on the landscape of Mono County. Additional crimes occur such as thefts and assaults due to drug use and the contentious nature of drug deals and drug dealers.

Drugs infiltrate into our schools and places of work and because of this, leave a destructive path. Drug trafficking remains a high priority for the District Attorney.



The investigators at the District Attorney's Office operated the Mono County Narcotics Program. With the reduction in staffing made by Mammoth Lakes Police Department over the years and the Sheriff's Department not participating in narcotics investigations anymore, the District Attorney took over all the administration and operations of the Narcotics Program in 2013.

The District Attorney's Office is also responsible for the assets seized in conjunction with narcotic offenses. The District Attorney proceeds against assets only in conjunction with a filed criminal case and once the criminal case establishes a predicate conviction allowing for the permanent seizure of the asset.

In 2017, the District Attorney terminated all operation of the Mono County Narcotics Program. The program became unsustainable based on allied law enforcement agencies not participating.

Welfare Fraud Specialized Investigative Unit (SIU)

Under an MOU with Mono County Department of Social Services, the investigators of the District Attorney's Office receive fraud referrals from social workers where fraud in obtaining benefits is suspected or has been reported.

The types of aid cases include General Assistance, which are County funds, as well as Food Stamps and Cash Aid, which are State-Federal funds. The referrals often include investigation of disqualifying factors such as being a drugsales convicted felon, being a fleeing felon, or claiming benefits for an incarcerated individual. The referral of fraud cases can lead to extensive financial investigations.

Elections

Year after year, the District Attorney Investigators also receive cases from the Registrar of Voters when there is an indication of voter fraud. It is common for voters to vote either multiple times in an election or to register in more than one county in order to vote multiple times.

In recent elections there have been efforts of second homeowners to register in Mono County, while maintaining a residence elsewhere, so as to have an impact in our local elections. The Office currently has several open cases of voter fraud allegations.


The Office of the District Attorney is designated by the Government Code as the primary advisor to the Grand Jury. As such, the District Attorney Investigators are tasked with and authorized under state law to issue subpoenas and conduct certain investigations for the Grand Jury.

Year after year, the Office routinely issues and serves subpoenas for the Grand Jury, assists in investigations, and the DA advises the Grand Jury on legal issues that they confront.



Public Administration

The Mono County Code and the California Government Code require the District Attorney to act as the Public Administrator. The duties of this position require an investigation to determine if a decedent has any next of kin and any assets. The primary responsibility is to secure the decedent's assets and utilize the court process to determine proper disposition of those assets.




Financial Crimes

Many financial crimes are highly sophisticated and require time consuming in-depth investigations. While our investigators assist all local law enforcement with their financial crimes investigations, many financial crimes investigations begin with the District Attorney's office. One of the principles used in these investigations is to "follow the money." It is not uncommon for a financial crimes investigation to take months, sometimes a year to complete.



Court Investigator High Tech Crimes Services

The District Attorney investigators are routinely called on by the court to conduct investigations on behalf of the court. In matters such as conservatorships, probate, guardianships, and adoptions, the investigators will conduct investigations and report specific criteria under consideration by the court. The court also refers matters to our investigators when someone claims their identity was used and they are not the individual that should be in front of the court.



The District Attorney's Investigators are trained in computer forensics, and the office has focused on acquiring the equipment and training in order to develop digital evidence from items used or associated with criminal activity.



Victim/Witness Services

The Mono County Victim/Witness Program is a division of the Mono County District Attorney's Office and provides free services to victims of all crimes as well as support services to families and friends.

Our Victim/Witness Program focuses on supporting and providing resources to victims and witnesses of crimes. Our advocates are available, dedicated, and compassionate professionals who receive specialized training in order to support

those affected by crime. We serve as critical members of the prosecution team who provide victims and witnesses with information, guidance and support throughout the criminal justice process.

Advocates facilitate the delivery of immediate crisis services and are available to accompany individuals to provide support on-scene, during interviews with law enforcement, attorney meetings and court hearings. The Victim/Witness Services Department works to ensure victims' voices are heard and that they are treated with fairness, respect and dignity.





Services Offered

CRISIS INTERVENTION – Crisis intervention counseling and support for victims.

EMERGENCY ASSISTANCE – Assistance with meeting immediate needs of victims, such as food, shelter, transportation, and medical care.

REFERRAL COUNSELING – Directing victims to community resources for assistance.

ORIENTATION TO THE CRIMINAL JUSTICE **SYSTEM** – Explaining the system and providing information about cases.

CASE DISPOSITION/STATUS – Keeping Victims/ Witnesses aware of the investigation and prosecution of their case.

PROPERTY RETURN – Ensuring the prompt return of property used as evidence.

COURT ASSISTANCE/SUPPORT – Assisting with court appearances, including providing transportation to and from court.

RESTRAINING ORDERS – Assist in obtaining restraining orders.

RESTITUTION – Helping to obtain court-ordered restitution from convicted offenders.

VICTIM OF CRIME CLAIMS – Assisting victims in preparing and submitting applications to the state to receive compensation for their losses, such as lost wages and medical expenses.


PRESENTATIONS – Promoting awareness of program services to the public, criminal justice agencies, and victim service organizations.

OTHER ASSISTANCE AS NEEDED – Child care referrals, creditor/employer intervention, notification to friends or relatives, etc.

A victim does not have to report a crime to law enforcement to be eligible for some of the services that the program provides.



Marsy's Law



The Mono County District Attorney supports California's Marsy's Law, which officially recognizes that victims of crime have rights under the State Constitution.

The Office invokes Marsy's Law to ensure that victims have an opportunity to be heard at every court hearing where their rights could be impacted, including allowing victims to speak at bail hearings, when defense attorneys seek a continuance, and prior to the court sentencing a defendant.


To protect victims' rights, the Office provides Marsy's Law services by advising victims of their rights by mail, online, and in person.

Rights and interests of victims are represented even decades after victimization by providing input for parole hearings against convicted felons.

Juvenile Division

The Office of the District Attorney is also responsible for the prosecution of juvenile criminal offenders. Criminal offenders who are under 18 years of age who commit either felony or misdemeanor offenses are handled by the Juvenile Division. Serious offenders may be prosecuted as adults. The Mono

County District Attorney's Office uses numerous programs to balance rehabilitation of juvenile offenders and the public safety.





Student Attendance Review Board (SARB)

The Juvenile Division is also responsible for the Truancy Program and Outreach. This is a cooperative effort by many agencies to address truancy and behavioral issues in the schools. The primary agency that addresses truancy is the Student Attendance Review Board. This Board is comprised of members from the District Attorney's Office, School Districts, Law Enforcement, Probation, and Health and Social Services. The primary goal of the Student Attendance Review Board is to keep kids in school.

Families and students are held accountable and offered assistance, services, and support to help the student be successful in school and beyond. SARB provides a progression of interventions, up to formal court action if necessary. When a student or family fails to respond to traditional efforts made by SARB the District Attorney steps in and represents the State in court to enforce compliance. Whether it's a morning phone call to wake a student up or court intervention, the goal is to get the student to graduation.

Education Through School

Members of the District Attorney's Office volunteer their time to teach students about the benefits of receiving an education. They also teach our students about the negative impact of narcotics, alcohol and sex crimes.

The District Attorney's Office provides scholarships to local High School students every year

Additionally, the Mono County District Attorney participates in advising, teaching and/or judging students who participate in the County's Mock Trial competition. The winner of that competition goes on to represent Mono County at the State Competition.

Government and Community Relations

The Office of the District Attorney is intimately involved in relationships with other governmental agencies as well as entrenched in each of the communities of Mono County. Although vigorous prosecution of criminal defendants is just one aspect of maintaining a safer community, there will never be enough police and prosecutors to keep the public safe if we do not reach out to all stakeholders in our County.



Attorneys, investigators, and staff are involved in every community throughout Mono County. We have members who volunteer their time in civic groups like Lions Club and Rotary. We have members that volunteer their time for the many community events that are held throughout our county and we have members who are invested in our kids' programs and schools.

The District Attorney's Office employs people who are passionate about the betterment of our communities because this same passion translates to employees who dedicate and contribute their talents and skills to public service and the Office of the District Attorney is all about public service.



Bad Check Program

For years, the Mono County District Attorney's Office has operated a Bad Check Program for individuals and businesses located throughout Mono County. When individuals and/or business have accepted a check, for merchandise or a service of any kind, that has been provided by that individual and/or business and cannot collect on that check for payment it can be turned over to the District Attorney for review under the Bad Check Program.

Under Penal Code section 470(a), if it appears that a check was written with the intent to defraud a party the District Attorney may charge the writer of that bad check with a criminal offense and will collect restitution and any out of pocket expenses as a result of the bad check on behalf of the party in which the debt is due.

District Attorney's Pre-Filing Diversion Program

This program allows low level first time criminal offenders to be diverted from the criminal system. Upon completion of the program their criminal charges are dismissed and their case is closed. This allows individuals who find themselves in the criminal system because of circumstances that are not within their character to avoid having a criminal record.

Funds that are collected for this program are donated back into the community for education and prevention programs, youth programs, as well as programs that are within the interest of the District Attorney's Office.

Programs and groups that have received funds from this program are the Mammoth High School sports program, Disabled Sports, Antelope Valley CERT team, Choose Civility Initiative, Mono County Mock Trial team, and many more. To date approximately \$10,000 has been distributed back into the community.

Hispanic Outreach


This outreach program is an opportunity to educate and explain the judicial system to our Hispanic population. The outreach has become an important vehicle for individuals to ask legal questions, learn about the criminal justice system, learn how various laws may affect them, and how they can avoid issues with the law. The outreach also informs them of the many services and support programs that are offered to individuals when they find themselves in the justice system.





Restitution Court

Victims often incur significant losses because of a crime committed against them. Victims incur property loss, loss of employment, insurance bills, and medical bills to name a few. Once a defendant is convicted, the court orders restitution to be paid by the defendant to the victim for any economic losses a victim incurred. Many defendants do not take this order seriously and either refuse or fail to pay. The District Attorney's Restitution Court was created specifically to ensure that victims recover their losses by monitoring a defendant's payments. This allows the District Attorney to vigorously pursue all legal avenues to ensure that a defendant fulfills their responsibility to the victim. Defendants that do not follow through with their restitution obligation are required to appear in court monthly and answer to the District Attorney and the Court for their failure to pay. The overall goal of any criminal prosecution is to make a victim whole again in hopes that the crime committed against them has a minimal impact on them and their life.



Mono County Multi-Agency Leadership Council (MAC)

The purpose of the council is to address and create procedures regarding matters of safety and security, and to promote a healthy, safe environment for the county's youth. The Council is made of representatives of school districts, law enforcement, and county and town staff.

Some of the issues that the Council has addressed are: tobacco enforcement, drugs/alcohol on/off campus, weapons on campus, student truancy, graffiti, sexual harassment, and underage sex.

Wild Iris

The Mono County District Attorney's Office works closely with and supports the services provided by Wild Iris. Wild Iris is dedicated to serving victims and survivors affected by domestic violence, sexual assault, and child abuse while remaining sensitive to culture, race, sexuality, gender, religion, age, class, disability status, immigration status, education, and geographic location within Mono County. Their services are provided at no charge, are completely confidential, and are provided with dignity and respect.

Because one of the priorities of the Office of the District Attorney is to curb the pattern of Domestic Violence, Wild Iris is an important component by assisting victims of crimes to understand that no one deserves to be abused. By providing and sustaining programs of education and prevention, crisis intervention, advocacy, and support for those affected by domestic violence, child abuse, and sexual assault, Wild Iris helps victims move forward while helping to prevent them from becoming victims again.




