1. Call to Order by Vice chair Julie Brown @ 6:05pm

 - b. New member Bob Marks, second homeowner since 1980s recently moved to JL fulltime. Interests include history, recreation, environment.
2. Officer Elections: nominate John DeCoster Chair, David moved, Julie seconded, passed. Julie Brown Vice-chair, Janet moved, David seconded, passed. Bob Marks Secretary, Julie moved, Jora seconded, passed.
3. Public Comment- Kevin Larsen still interested in speed bumps on Bruce St. for spring/summer. Planning staff request update on this from Tony and Public Works.
4. Review/Approve 12/4/19 and 1/9/19 Minutes. Janet moved, David seconded, passed.
 - a. Janet moved to approve, Julie seconded, passed.
5. Reports
 - a. Supervisor Gardner
 - i. Board of Supervisors in Coleville yesterday. two cannabis applications considered, one manufacturing, one cultivation. Lots of interest from community 80 % opposition. Board of Supervisors voted 3-2 to deny cultivation permit.
 - ii. Suicide prevention County behavioral health event tonight. Bob suggested event in June Lake. Mental health is a stigma we need to break. Encourage people to seek mental health services. Behavioral health is free and has additional funding.
